WHEREAS, the Board of County Commissioners of Archuleta County, Colorado, has heretofore adopted regulations relating to the consolidation of lots in Archuleta County, Colorado, (Resolution No. 2013-23); and

WHEREAS, the Board has received an application from Marty G. Ryan, Trustee of the Marty G. Ryan RLT dated December 2, 2015, to consolidate certain lots in Archuleta County pursuant to the regulations heretofore adopted by the Board; and

WHEREAS, the Board has found that Marty G. Ryan, Trustee of the Marty G. Ryan RLT dated December 2, 2015 has met all the requirements contained in said regulations for Lot Consolidations and the Board may consolidate the hereafter mentioned lots; and,

WHEREAS, it was discovered that Resolution 2021-24 which was adopted by the Board on April 13, 2021 was missing key information and needed to be corrected.
