Chairman Maez recessed the Special Meeting and convened the Executive Session at 8:31 a.m.


Chairman Maez reconvened the Special Meeting at 8:39 a.m. and advised no decisions were made while in Executive Session and continued with new business.

A. Candidates for County Administrator and Instruct Negotiator


Commissioner Wadley moved to select Scott Wall as the finalist for the County Administrator position. Commissioner Schaaf seconded the motion and it carried unanimously.

With there being no further business before the Board, the meeting was adjourned at 8:40 a.m.

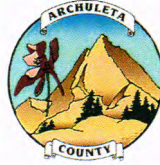
