

RESOLUTION 2022- ____

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ARCHULETA COUNTY, COLORADO ASSIGNING A NAME TO FIVE (5) PREVIOUSLY PLATTED, UNNAMED ROAD SEGMENTS LOCATED IN SECTION 6, T.34N., R.1W.,; SECTION 1, T.34N., R.1 1/2W.; AND GLO LOT 1, SECTION 1, T.34N., N.M.P.M.

WHEREAS, the Board of County Commissioners established an Addressing Policy by Resolution No. 79-66 to accurately and specifically identify the location of homes, buildings and parcels of property for many purposes including mail and package delivery, voter registration, and fire, police, medical or other emergency services; and

WHEREAS, Section 27.0.3 of the Road and Bridge Standards provides a process for road numbering and naming, to eliminate duplication and similarities of street names, provide names where none exist, and make such changes as are appropriate to avoid confusion and delay in finding streets and addresses; and

WHEREAS, for the reasons described above, by way of this Resolution, Five (5) previously platted and unnamed road segments, the first (1) is approximately .65 mile in length, intersecting with W Blue Lake Dr approximately .3 mile from its intersection with Clearwater Dr and E Blue Lake Dr. This roadway shall be named "Chamisa Pl". The second (2) is approximately .14 mile in length, intersecting with Chamisa Pl approximately 680 feet from its intersection with W Blue Lake Dr. This roadway shall be named "Gambel Oak Ct". The third (3) is approximately 661 feet in length, intersecting with Chamisa Pl approximately .27 mile from its intersection with Gambel Oak Ct. This roadway shall be named "Alder Pl". The fourth (4) is approximately 220 feet in length, bearing southward from the terminus of Alder Pl. This roadway shall be named "S Hickory Ct". The fifth of which (5) is approximately 703 feet in length, bearing northward from the terminus of Alder Pl. This roadway shall be named "N Hickory Ct". These roadways are depicted by the map attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ARCHULETA COUNTY, COLORADO AS FOLLOWS:

1. The Road segments is hereby named as follows:
"Chamisa Pl", "Gambel Oak Ct", "Alder Pl", "S Hickory Ct", and "N Hickory Ct".
2. All properties affected by the naming of the Roadways shall be re-addressed with the aforementioned names as appropriate.
3. County staff shall take all necessary measures to ensure references to the Road and affected residences are updated including, but not limited to those in or on: official County records, other County offices, emergency service agencies and the local U.S. Postal Office.
