I would like to dispute any late fees associated with the renewal of my liquor license. In the past I have repeatedly not received a renewal in the mail. I tried to request renewals to be sent via email, but they wouldn't do that. Generally I would look up at the license and realize I was right at my expiration date and then in desperation hurry up my renewal process. Last year I had to pay \$1,000.00 in late fees due to this issue. This year I remembered that when my birthday (23rd) came around, I should begin my panic to get things done in time before the license expires. This year I remember on my birthday and lo and behold, the renewal arrived in the mail that day. Oddly enough, it had an August postdate on the envelope.

Years ago I had an issue with our mail carrier. Because of the continuing problem, I made a formal complaint. That resulted in my mail carrier deciding on his own to return my mail, keeping or destroying my mail, giving my box away, etc. I've learned just to live with it and be as nice as I can just so I can get my mail.

A couple months ago I had yet another incident where I didn't get my mail for over a month. I called the post office to inquire and my mail carrier (same person) got on the phone and cussed me out. I was accused of all sorts of things (just like years ago) as meeting with the post master on this issue, not picking up my mail, signing an agreement on these issues, etc. Once again I argued this point as this had never happened, but I got the same results. I didn't get mail for weeks at a time, then received bills, etc. weeks, even months late. I'm convinced this is the case in my renewal. I've even had my banks call me because my mail was being returned to them.

I have made several formal complaints (copies available upon request) however it just makes the situation worse. I inquired on a box at the local UPS store, however their charges were so high.

Like I mentioned before, I relied on a date to remind myself just in case I, once again, did not receive the renewal in the mail, which was my birthday. That day was clearly before the expiration day so I figured it would be safe.

I attempted to take care of this on Tuesday, but then learned that Flora was no longer in the office on Lewis Street and it was too late in the day to reach out to her at her new location. Wednesday I showed up and was told she had already left for the day as there was a meeting she was going to. Thursday we met up and I elected to bring the paperwork back the following day so I could include this letter of explanation and request to waive the late fees.

With all respect I am requesting a waiver of late fees. The additional costs would be financial devastating at this point. My renewal and fees are submitted prior to my expiration date and if I had received my renewal on a timely basis, it would have been done at that time. I run another business during the day and my time is limited so I try to create as many reminders as I can for things just like this and thought I was doing pretty good. Thank you for your consideration.

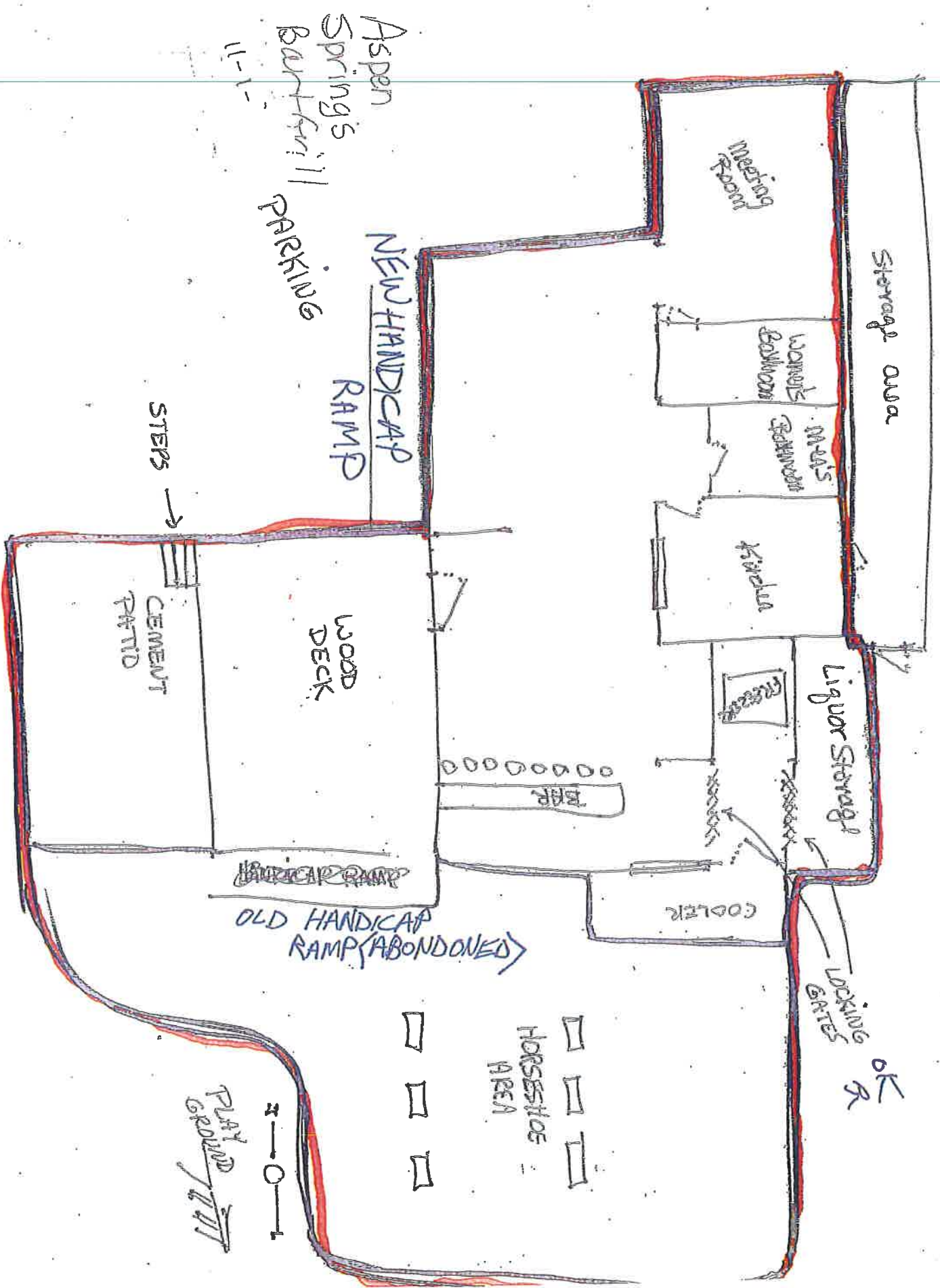
