
Chairman Maez called the Special Meeting to order at 8:00 a.m.

New Business

A. Appointment to Fill the Coroner's Vacancy


Derek Woodman, County Manager, stated Brandon Bishop resigned his position effective April 16, 2023 as County Coroner. State Statute provides that the Board of County Commissioners shall be the body responsible for the appointment of an official to fill a vacancy of the unexpired term of an elected official. Mr. Woodman stated he spoke with County Coroner Brandon Bishop and asked him to extend his date of resignation until April 18, 2023 until his recommended replacement would be back in town to take her Oath and be sworn in as Interim County Coroner. The extension was to avoid a gap between the end of his service and start of Interim Coroner. **Commissioner Brown moved to delay the decision until Monday or until a letter is in hand and are better able to appoint an Interim Coroner. The motion died for a lack of a second. Commissioner Medina moved to appoint Steve Wadley as Interim County Coroner to fill the unexpired term of Coroner contingent upon State Statute not to exceed thirty days while the permanent Coroner position is advertised. Commissioner Maez seconded the motion and it carried with Commissioners Maez and Medina voting Aye and Commissioner Brown voting Nay.**

With there being no further business before the Board the Special Meeting was adjourned at 8:17 a.m.
