

**ARCHULETA COUNTY PROCEEDINGS
BOARD OF COUNTY COMMISSIONERS**

The Archuleta County Board of County Commissioners, sitting as the County Board of Equalization held a Special Meeting to hear petitions on valuations for assessments on taxable property in Archuleta County on July 25, 2023, with County Commissioners Ronnie Maez, Veronica Medina and Warren Brown, County Attorney Todd Weaver, Deputy County Assessor Natosha Smith and County Clerk & Recorder Kristy Archuleta present.

Chairman Maez called the Special Meeting to order at 11:00 a.m.

Chairman Maez asked everyone to turn off or silence their cell phones.

Vaughn McGinnis, R014690, Parcel #589109102002, Pagosa Meadows 4

Vaughn McGinnis, Owner, was requesting a value of \$78,873. The Assessor's value was \$118,940. **Commissioner Brown moved to not uphold the Assessor's value of \$118,940 for tax year 2023 for Parcel #589109102002 owned by Vaughn McGinnis and to adjust to \$102,880. Commissioner Maez seconded the motion and it carried with Commissioners Brown and Maez voting Aye and Commissioner Medina voting Nay.**

Betty Church, R014745, Parcel #589110103003, Pagosa Meadows 4

Betty Church, Owner, was requesting an amount of \$169,000. The Assessor's value was \$209,920. **Commissioner Medina moved to uphold the Assessor's value of \$209,920 for tax year 2023 for Parcel #589110103003 owned by Betty Church. Commissioner Brown seconded the motion and it carried with Commissioners Medina and Brown voting Aye and Commissioner Maez voting Nay.**

seconded the motion and it carried with Commissioners Brown and Maez voting Aye and Commissioner Medina voting Nay.

Martin Zenthoefler, R014815, Parcel #589115101009, Alpine Hills

Martin Zenthoefler, Owner, was requesting a value of \$1,550,000. The Assessor's value was \$2,018,000. Commissioner Brown moved to not uphold the Assessor's value of \$2,018,000 for tax year 2023 for Parcel #589115101009 owned by Martin Zenthoefler and to adjust to \$1,958,000. Commissioner Medina seconded the motion and it carried unanimously.

Commissioner Brown moved to uphold the Assessor's value of \$696,180 for tax year 2023 for Parcel #569916311012 owned by Donald R. Ortiz. Commissioner Medina seconded the motion and it carried unanimously.

Deborah Bridges, R007720, Parcel #569916320010, Pinon Condos

Deborah Bridges, Owner, was requesting a value of \$220,000. The Assessor's value was \$298,190. Commissioner Brown moved to not uphold the Assessor's value of \$298,190 for tax year 2023 for Parcel #569916320010 owned by Deborah Bridges adjusted to \$290,667.

Commissioner Maez seconded the motion and it carried with Commissioners Brown and Maez voting Aye and Commissioner Medina voting Nay.


Yount Living Trust, R007704, Parcel #569916319006, Pinon Condos
